The Pampa EDC Board of Directors will set aside time during each regularly scheduled meeting to permit public comment from the floor. **Public Hearing**

A public hearing will be held to consider a loan in the amount of \$162,800.00 with a portion of the loan forgivable in the amount of \$80,000.00 to Tyler D. Grant owner of Jump N' Jive. The forgivable portion will be based on the number of total hours paid in 2014. The credit for the loan will be taken off the principal of the loan each year on the anniversary date for five years. Any # of hours credited over the base # in 2014 will apply with the example of 1000 additional hours equals \$5,000.00. Video game and laser tag equipment in the amount of \$127,000.00 will be held as collateral for the loan.
