A public hearing will be held to discuss a grant in the amount of \$77,000.00 to CP Tactical Solutions, LLC. with an interest rate of 5% for a period of seven years and six months with monthly payments to begin the first day of the 7<sup>th</sup> month after funding, interest free for the 1<sup>st</sup> six months with payments due the 1<sup>st</sup> day of each month, the loan to be personally guaranteed by Chauncey Paris and wife Catherine Paris, loan to be secured by current company owned equipment as well as the equipment to be purchased, loan forgiveness for each full-time employee (or employee equivalent – 2080 hours per year), employed for 12 months, not including Chauncey Paris or wife Catherine Paris.
