Pampa Optimist Youth Club Phase II Project

POYC is requesting a grant in the amount of \$11,000.00 for lighting in the gym, \$5,000.00 for miscellaneous electrical expenses and \$5,000.00 for a floor buffer/cleaning machine for the gym, for a total grant of \$21,000.00 on phase II.
