<u>Presentation by David Teichmann – Hidden Hills Golf Course</u>

Mr. Teichmann is requesting a grant in the amount of \$85,000.00 for improvements to Hidden Hills Golf Course and the Pro Shop, such as, adding sprinklers and leveling #13 fairway, remodeling both restrooms in the Pro Shop, new carpet and tile in the Pro Shop area, new paint in the Pro Shop and adding a new #1 tee with irrigation.

During the presentation Mr. Teichmann explained the golf course was a quality of life issue, it draws in people and stated there were players from the ages of 3 to 93 years old. Mr. Teichmann stated there is a fine line on determining the fees to service all the community. Mr. Teichmann, City Manager Shane Stokes and the Director of Fees are analyzing the current fees. Discussion was held about the wear and tear of the building which is 31 years old and the upkeep of the golf course.

Report from Clay Rice, Executive Director
